#### Call to Order

• IEC Vice-Chair Pete Olsen called the meeting to order at 3:00 p.m.

#### **Welcome and Committee Member Introductions**

- Vice-Chair Olsen welcomed everyone and made opening statements.
- Ms. Toni Burton called roll. The list of attendees/absentees is above.

#### **Verification of Agenda Posting**

• The agenda for this meeting was posted in accordance with NRS 241.020.

#### **Approval of Agenda**

- One change to the agenda was made, which was the deletion of Agenda Item 7 (Presentation by the Yomba Shoshone Tribe).
- A motion was made by Ms. Shayla Hudson, Pershing County, to approve the agenda with the deletion of Agenda Item 7; the motion was seconded by Mr. J.J. Goicoechea, Eureka County. IEC members approved the agenda with the noted revision with no dissent.

#### **Public Comment**

- Vice-Chair Olsen opened the floor for providing public comments on the agenda, noting a
  three-minute time limit per person. Action will not be taken on the matters considered during
  this period until specifically included on an agenda as an item. The meeting moderator, Ms.
  Allison Turner, reviewed the instructions for providing public comments.
- No public comments were received during this public comment period. The public comment period was closed.

#### **Old Business**

There was no old business to address at the meeting.

#### Approval of Meeting Minutes from April 11, 2022

• There were no changes to the meeting minutes from April 11, 2022. A motion was made by Mr. Goicoechea, Eureka County, to approve the meeting minutes; the motion was seconded by Captain Tanner, NASF. IEC members voted to approve the meeting minutes with no dissent.

#### **Discussion/Possible Action: Navy Update**

#### Legislative Update

- Captain Shane Tanner introduced Mr. Karnig Ohannessian, Deputy Assistant Secretary of the Navy, Environment and Mission Readiness, to the committee.
- o Mr. Ohannessian provided a status update on the legislative activities for the Fallon Range Training Complex (FRTC) modernization proposal. The Navy has submitted a legislative proposal to modernize the FRTC for the fiscal year 2023 National Defense Authorization Act. Mr. Ohannessian noted that, at the Nevada Congressional delegation's request, the Office of Management and Budget has taken the unprecedented step of including the Congressional delegation in the discussion of the administration's legislative proposal prior to transmitting to Congress. Mr. Ohannessian

stated that the Navy is supportive of mitigation measures and is mindful of the potential unintended consequences of modernization. He acknowledged there are still hard issues to work through, but the Navy remains committed to working with Tribes and stakeholders to find win-win solutions for both the Navy and Northern Nevada.

#### Questions/Comments

- Mr. Jim Lawrence, Acting Director of the Nevada Department of Conservation and Natural Resources, asked if there was anything that the IEC, his Department, or the State could do to facilitate getting agreements in place, to which Mr. Ohannessian replied that there is nothing specific or additional at this time except to continue with their work and involvement.
- Vice-Chair Olsen read a written statement on behalf of Churchill County. The County expressed that they are opposed to the Navy's legislative proposal, which they feel does not include key provisions for minimization and mitigation of impacts. The County added that they support the amendments developed and offered by the Nevada delegation.
- Mr. Goicoechea subsequently asked about the timeline and if the Navy was going to re-engage with Churchill County and local governments more, noting the importance of early-on coordination and involvement.

#### Cultural Resources Survey Update

- Mr. Mike Baskerville, Archaeologist, NASF, updated the IEC on the cultural resources surveys on the NASF ranges, the new Programmatic Agreement (PA), and the new Integrated Cultural Resources Management Program (ICRMP).
  - B-20: The Navy is in the process of inventorying 18,000 acres in the proposed B-20 range expansion area. Crews have completed surveys of approximately 56,000 acres of B-20 to date. Each field crew has a minimum of one Tribal archaeological technician assigned to them. Typically, there are three to five technicians on each rotation. The southwest corner of the inventory area is still flooded and will hopefully be accessible by the end of the summer. The inventory is expected to take two years.
  - B-16: This range inventory was 100% inventoried as part of the Environmental Impact Statement (EIS) process. Those inventories covered approximately 22,538 acres and documented or re-documented approximately 375 cultural properties. Inventories associated with construction of the B-16 boundary fence have been completed. The Navy is in the process of consulting on the effects of that fence with local Tribal representatives as well as the State.
  - B-17: Approximately 12,389 acres of B-17 were surveyed as part of the EIS process. Those inventories documented or re-documented 511 cultural properties. New inventories are being planned for B-17. The Navy sent out a draft work plan to Tribes and is in the process of receiving comments, which will then be incorporated into the plan.
  - PA: A new PA is being developed and is expected to be shared with Tribes in September 2022.
  - ICRMP: Development of a new ICRMP is being planned and will begin once the outcome of the modernization legislation is determined.
- o IEC members had no questions for Mr. Baskerville.

#### Tribal Engagement Update

Ms. Kish LaPierre, Tribal Liaison, NASF, provided an update on Tribal engagement.

- Ms. Pierre showed a map of the 13 federally recognized Tribes in Northwest Nevada with whom the Navy consults and that may be directly or indirectly affected by activities of NASF.
- The Navy has initiated studies within the area of potential effect with respect to proposed expansion, including archaeological pedestrian surveys and ethnographic studies. Some of these studies will focus on known culturally important sites significant to Tribes and areas that have not yet been inventoried. The Navy has committed to identifying these important locations and studying them in conjunction with Tribal partners and involvement.
- The Final Draft MOA for Tribal access was emailed to Tribal partners on March 18, and mailed on March 21, 2022, for review and signature. Tribal partners are reviewing the MOA.
- Far Western, the contractor for the archaeological and ethnographic studies, has obtained considerable Tribal participation in the studies. Studies will resume in September.
- The Navy has committed to protecting burials in areas where a burial probability is at an increased risk. The Navy is kicking off a Native American Graves Protection and Repatriation Act (NAGPRA) study with Tribes with regards to two sets of human remains housed at the Nevada State Museum in Carson City.
- Upcoming B-17 archaeological studies will be kicking off with Tribal cultural experts in the field. Tribes are encouraged to comment on the work plan (as mentioned by Mr. Baskerville).
- The Navy received considerable input from Tribes on the Wildland Fire
   Management Plan. The Navy incorporated Tribal perspectives and issues, and a revised final draft will be distributed to all Tribes.
- Several archaeological sites were identified during the archaeological surveys for the B-16 fence project. Tribal consultation is ongoing and field visits have been completed. The Walker River Paiute Tribe offered the Navy a mitigation plan, which will be incorporated into the final report. Ms. Pierre thanked Tribes for participating in those efforts as well as consultation efforts with the State Historic Preservation Office.
- For the Off-Range Ordnance project, the Walker River Paiute Tribe is currently reviewing and commenting on the Preliminary Assessment Draft Report and the Munitions Response Site Prioritization Protocol.
- State Route 361 proposed realignment is a topic of concern to the Yomba Shoshone Tribe due to the proximity to their reservation. Captain Tanner visited the Tribe on July 6, 2022, to discuss the proposed road realignment. The Navy will continue to consult with Tribes on this proposal.
- Captain Tanner, the new commanding officer at NASF, is working on meeting with all 13 Tribes with whom NASF consults. He is committed to working with the Tribes.

#### Questions/Comments

IEC members had no questions for Ms. LaPierre.

#### **Call for Agenda Items for Next IEC Meeting**

- Mr. Ken Gray, Lyon County Commissioner, noted that it would likely be his last meeting, and offered thanks and appreciation to everyone.
- There were no other public comments, and the public comment period was closed.

## **B-20 Inventories**



- Inventory of 118,000 Acres of B-20 Range expansion
- Inventory is resuming after summer hiatus
- Crews have inventoried approximately 56,000 acres
- Each field crew has a minimum of one Native American Archaeological Technician assigned.
- Field inventory is expected to take two years to complete



## **B-17 Inventory**



- Approximately 12,389 acres of inventory was conducted as part of the FRTC EIS effort.
- Documented or re-documented approximately 511 cultural properties.
- The Navy has sent out a draft work plan to the Tribes in May.
   Finalized version is being prepared.
- Additional Inventories are being planned with FY23 funding.
   Work plan for that inventory will be sent out for comment. It should be a duplicate of finalized work plan.



## **Greenbelt Survey**



- Inventory of 2,800 acres of primarily agricultural lands on NAS Fallon.
- Misty Brenner served as Native American Archaeological Technician.
- Inventory documented 75 sites, 17 isolated features (IFs), 71 isolated occurrences of artifacts 34 (IAs), 19 historical-period archaeological structures, and 12 irrigation structures.
- 46 properties recommended eligible, 29 were determined ineligible.



## Fallon ICRMP and PA Development



- A new Programmatic Agreement (PA) is being developed. Procedures will be consistent with the protocol agreement currently being used by the Bureau of Land Management
- Development of a new Integrated Cultural Resource Management Plan is being planed for. Its development will begin after outcome of FRTC is determined.

















